### **Topic: Water System Operations and Concerns**

TCEQ 3 Year Inspection Report Update Discussion: President Serene received the names from the BSTWSC water operator of two TCEQ-approved inspectors able to perform ultrasonic inspections of the water system pressure tank. Both are from the Austin area. One provided an estimate of \$750.00 (detailed flat fee), and the other charges by the hour and estimated his fee at \$500.00.

Vice President Watson has been unable to obtain a final estimate and update for replacing the alternator and chlorinator pump. The Board agreed to table these items until the next regular board meeting.

President Serene informed the Board that the BSTWSC Water Operator has been approved to take the New Construction Inspector exam (for backflow water prevention). The date for his exam is still pending. Jason must take and pass the exam prior to conducting any new construction inspections. This item is tabled until this action is completed.

## Bear Springs Trails Water Supply Corporation Meeting Minutes

Vice President Watson provided his more detailed cost estimate/findings in regards to the purchase of a back-up generator. The generator is estimated to cost approximately \$5,000.00. Another \$300.00 will be needed for the concrete pad. \$300.00 for electric disconnect work. \$250.00 for conduit and accessories. A propane tank with initial fill will cost approximately \$2700.00. \$900.00 is needed for wiring. The overall cost of a back-up generator is approximately \$10,000.00. VP Watson has identified a master electrician willing to do the work at cost and/or a low cost. After discussion, the Board unanimously agreed to suspend approval of the purchase of a backup generator until BSTWSC has greater reserves in the bank account. This may be an item for discussion at the annual membership meeting.

There is no new information from BST Owners Association President Ray Nolan regarding the establishment of an audit committee(s) for both the owners association and BSTWSC water company. There has also been no further information from water customer David Ketterer since providing him with the financial records of the water company.

President Serene notified the Board that he had received a complaint from a water customer this morning (December 10, 2018) regarding his water pressure. The customer claimed that he normally receives 60 psi at the meter, but lately he was only getting 50 psi at the meter, and during the evening hours it drops below that. He didn't provide an actual psi for how low it gets at the meter, but by the time it gets to his house, it can be as low as 20 psi. This is a problem for him. The customer acknowledged that VP Watson had already visited his home to investigate the pressure at the meter where his two readings measured 50 and 60 psi. VP Watson's assessment is that the homeowner/water customer is having problems. It is not a water system problem as TCEQ only requires that the water system deliver 30 psi to the meter. The recommendation to the water customer is to have a pressure booster installed to boost the pressure between the meter and his home if he is unhappy with the water pressure at his house. Note: The water customer is responsible for the cost of installing a pressure booster as this is not a water system issue.

Vice President Watson informed the Board that he would be following up with J&L Plumbing to schedule a repair of a known water system leak. The Board inquired if a water system shutdown would be required, and VP Watson agreed to inquire.
